In October 2022, we presented "TOMORROW," an immersive experience focused on the live premiere of Damien Geter's "Cantata for a More Hopeful Tomorrow," with custom projections in the performance space and both displayed artwork and interactive artmaking in adjacent spaces, all at Live! At 10th and G in downtown DC.

This year also included the continuation of our high school SIDE BY SIDE program, where The Washington Chorus shares the stage with the next generation of choral singers. Each year, the Side by Side program selects up to two outstanding local high school choruses to partner with The Washington Chorus for the unique experience of rehearsing and performing alongside a world-class symphonic chorus on the Kennedy Center and Strathmore Concert Hall stages. During the Candlelight Christmas concerts, the high schools perform their own set of music as well as sing within full chorus. This year the schools chosen were the Reservoir High School High School Chamber Choir under the direction of Gregory Knauf, and the Stafford High School Chamber Singers under the direction of Joseph Eveler.

Guest appearances this season were numerous. The Chorus headlined "JOYFULLY TOGETHER," a festival of choral ensembles from around the National Capital Region, at Wolf Trap National Park for the Performing Arts in September 2022. In January 2023, the Chorus sang VERDI REQUIEM with the Baltimore Symphony Orchestra under the baton of James Conlon. Also in January, members of the Chorus joined the SPHINX EXIGENCE ensemble and the SPHINX Symphony Orchestra in concert at the Kennedy Center. In June 2023, the Chorus sang BEETHOVEN'S NINTH SYMPHONY with the National Symphony Orchestra under the baton of Gianandrea Noseda to sold-out audiences at the Kennedy Center. These performances were professionally recorded for future commercial release.
